In 2016, CASDA provided Sexual Assault Program services to 124 victims and survivors of sexual violence.

The CASDA Children's Program provided direct services to 86 children, and provided education about protective behaviors, healthy relationships and teen dating violence at 7 local elementary, middle and high schools.

The Douglas County Sexual Assault Coordinated Community Response Team (SA-CCR) is hosting a free event to recognize and reflect on Sexual Assault Awareness Month.

# **ACES Explained:**

What They Are and How They Relate to CASDA's Mission By Kim Marble-Follis, Bayfield County Outreach Advocate

Note: Originally conducted between 1995 and 1997, the CDC-Kaiser Permanente Adverse Childhood Experiences (ACE) Study is one of the largest investigations of childhood abuse and neglect, and later-life health and well-being.

ACE (Adverse Childhood Experience) studies were designed to assess the root cause of behaviors exhibited by individuals eventually labeled as "high risk" as adults. These studies revealed that children exposed to specific adverse experiences had remarkably more difficulty as adults in handling daily responsibilities, raising children, forming healthy relationships and, most often, developed addiction issues when trying to cope with life challenges.

Exposure to any of the following experience, before the age of 18, was examined:

- Recurrent emotional abuse
- Sexual abuse
- Recurrent physical abuse
- Alcohol or Other Drug (AODA) abuser in the home
- An incarcerated family member
- Parental separation or divorce
- A chronically depressed, mentally ill, institutionalized or suicidal household member
- Violence witnessed between adults in the home and/or other significant role models in child's consistent environment

Higher "scores" (or number of Adverse Childhood Experiences) correlated with major health problems in later life. Individuals with these higher ACE scores reflect the population we encounter or serve at CASDA.

ACE studies have helped service providers such as CASDA understand why victims do what they do and have confirmed our belief that all victims should be provided advocacy assistance with a "trauma informed" point of view: being mindful of what victims have gone through prior to walking through our doors to seek help.

As advocates, we can help spread the word about the trauma-informed care approach, and we can listen to what survivors are willing to share regarding the adverse experiences they were subjected to as children. Trauma-informed advocacy can help build resilience and improve the coping skills of those who experience abuse in their adult lives on top of what they already suffered in childhood.

### CASDA'S BOARD OF DIRECTORS MAKES A DIFFERENCE



In December 2016, CASDA Board Member Sarah Mayne created a video, "This Healing Place," to highlight the role of CASDA in our community and to help convey some of the real barriers encountered by victims and survivors in our midst. The video premiered at CASDA's New Year's Eve Gala and is now posted on our web site for anyone who would like to take a closer, behind-the-scenes look at CASDA's programming.

CASDA was humbled by the extra time and effort that filmmaker Sarah contributed to complete this project,

and we recently had the pleasure of interviewing her about the filming process. A much longer version of this interview appears on our web site.

**CASDA:** What drew you to serve on CASDA's Board of Directors, Sarah? **Sarah:** Initially I wanted to be more involved in my community. Luann LaValley was on the board and is someone I look up to. She's a legend at Minnesota Power. I saw this as an opportunity to grow personally and professionally.

**CASDA:** Have you found that being a board member has supported your personal and professional growth?

**Sarah:** Absolutely. This is a great board to make impactful work. It surprised me how involved and "front line" this role can be, and I am all in!

**CASDA:** Tackling a video project can be quite time consuming. What motivated you to create this project for CASDA?

**Sarah:** What really motivated me is wanting to give a voice to CASDA and the survivors served, to give survivors a voice of dignity and justice that could also reach through any assumptions that people might make.

CASDA: Shooting the video may have given you, as a board member, a different or deeper look at CASDA's operations. Were there any surprises for you?

Sarah: I don't think there were any surprises, but there was confirmation that people working at CASDA are very dedicated, passionate and there for all the right reasons. The opportunity to interview a survivor was humbling. I came out even more convinced that I had to let the world know what had happened to her and in some way bring about some form of redemption. I also wanted to highlight the impact that CASDA has with healing and supportive services. The last interview I did was with Superior Police Chief Alexander and he was saying the same things as all of CASDA's staff regarding the critical services that are needed. If CASDA weren't there to fill that need in the community, the community would suffer greatly.

### New Advocacy Positions at CASDA Enhance Critical Community Services

Three new full-time advocates have joined CASDA's team: two employed by CASDA, and one by First Witness Child Advocacy Center.



Thanks to funding

through the Victims of Crime Act (VOCA), a **Triage Advocate, Jenna Monnier**, and an **Outreach Advocate, Martina Tendrup**, joined CASDA's staff last fall. When people first reach out to CASDA for help, the Triage Advocate assesses their needs, provides initial crisis intervention and directs them to the appropriate CASDA program and/or community resource for further assistance. The Outreach Advocate is a highly mobile source of support for survivors of abuse who have met some of their initial goals within other CASDA programs but desire ongoing meetings with an advocate to help ensure their continued safety.

Prior to joining CASDA, Jenna spent five years working in education. She has a passion for working with diverse populations and loves learning as much as teaching. Her passion is fueled by her hope that the way she lives her life and the work that she does will cause positive change in the culture and political climate for women and minorities.

Martina started working at CASDA as a Shelter Advocate and says she found her true passion here. A lifelong Superior resident, she received her Bachelor's degrees from UWS, where she learned how important it is to be a part of her community, affecting change from the ground up. She says she is honored to work with the people most impacted by domestic violence as they work tirelessly to build better lives for themselves.

Sharing office space with Jenna and Martina is "Heart for the People" Community Advocate Jessica Unkelhauser, whose program is funded through the Opportunity Gap grant awarded to CASDA, First Witness and All Nations Indigenous Center by the Duluth Superior Area Community Foundation last year. Jessica and her fellow Community Advocates (each housed at a different participating agency) provide street outreach, advocacy, and information and referral services to parents engaged in social services or family court matters involving the safety and protection of their children.

Jessica has worked in the area of direct service to people in need for over 17 years. She earned a Bachelors of Social Work at UWS and Masters in Social Work at UMD. She says she is blessed to be mother of two beautiful girls, three cats and one dog; her time away from work is always spent with them. Her belief that people should be afforded opportunity, support and information fuels her drive in her advocacy work.
